## **DEMANDS**

- **The government must provide funds for all families to be reunited. The databases of FEMA and the Red Cross must be made public.**
- The \$50 billion belongs to the victims of Hurricane Katrina. We demand a Victims Compensation Fund as was done after 9/11 for the people in the World Trade Center in New York City.
- The People's Committee demands representation on all boards that are making decisions on spending public dollars for relief and reconstruction. We also demand that those most affected by Hurricane Katrina be part of the planning process.
- We demand public work jobs for the displaced workers and residents of New Orleans and the Gulf Coast. We must take a lead in the rebuilding of our communities. The jobs must be at union wages so that our population is no longer characterized by extreme poverty.
- We demand transparency in the entire reconstruction process. Citizens must know where all the monies are being spent and with whom they are being spent.
