#### **January Meeting**



Tuesday, Dec.4 The Save Our Post Office Coalition of SF, Save the Berkeley Post Office, Berkeley-East Bay Gray Panthers, SF Gray Panthers, Living New Deal, Grandmothers Against War, and current postal workers, told Richard Blum, CBRE, Inc.

"Stop selling our post offices!" Occupy SF & Occupy Oakland camped out over night in front of Blum's financial district office with tables of information on CBRE. We marched from there through the financial district to Senator Feinstein's office. After a rally outside, a delegation led by Margot Smith of Berkeley-East Bay Gray Panthers entered Senator Feinstein's office, and met with her aide who encouraged the delegation to tell Congresspersons to call a hearing. Feinstein just happens to be the spouse of Richard Blum, and, as Richard Koritz of N. Carolina State Assoc. of Letter Carriers said at the rally- "what an example of a marriage between political and corporate corruption." Since 1971, post offices have not received any tax dollars. Compare that to the bank bailouts with our tax dollars.

#### **Free MUNI For Youth**

# **Oakland Police Department Under Fire**

The Oakland Police Department {OPD} narrowly avoided being the first local police agency in the country to be placed in federal receivership when

First African American lawyer to work for the Justice Department's Civil Rights Division: active in the legal struggle to end racial discrimination in the South. on Dec.12 US District Judge Thelton Henderson approved an Oaklandcivil rights lawyers agreement to appoint an independent "compliance director" with broad oversight powers over the OPD. The compliance director will be appointed by the judge to prepare plans and timetables to reduce the unjustified use of force, racial profiling, high speed chases, and complaints of police misconduct, and improve the investigation of citizen complaints. He/she will have the authority to demote or fire the police

chief and other top brass.

As this newsletter reported previously, the OPD has been subject to federal court oversight for the past 10 years as a result of the Riders case, in which four OPD officers were convicted of running wild in West Oakland. At that time the city agreed to make 50 changes in police practices. The court-appointed monitor reported that 10 of these changes have not yet been implemented. They include a system to track at-risk behavior by an officer - unusually high number of arrests, use of force, pointing of weapons - high tolerance by commanders of such behavior, poor oversight of stop data (an effort to control racial profiling), failure to turn on lapel cameras, use of confidential informers to justify stops and pointing weapons, poor handling of officer involved shootings, the violent, military type response to the Occupy protests, and no negative consequences either to officers or the command staff.

Civil rights observers say this illustrates a broken police culture with no political will to change. The court will be keeping a very close watch on results with full federal receivership always a possibility.

#### Reported in December

As if to underline the OPDs problems, Oakland paid \$4,600,000 to settle a suit by 39 men who were pulled out of their cars and strip-searched in public. And two federal civil rights suits were filed against the city resulting from Occupy police violence.: one by Robert Ovetz who was hit in the abdomen and back by Officer Ercivan Martin while not resisting, then arrested and jailed but the case against him was dismissed; and the second by Iraq vet Scott Olsen who was hit in the head by a beanbag and critically injured, and while he was lying on the ground, Officer Robert Roche lobbed a tear gas canister at a group trying to help him.



## **Tasers: the Gun Culture**

Dec 6, SF Board of Supervisors held a hearing called by John

Avalos on the use of tasers. SFPD Chief Greg Suhr wants to equip his department with 100 or so electric stun guns as part of a new pilot program that would specifically train officers to handle mentally ill people. Avalos raised concerns stating "We haven't done the work on developing the crisis response that we can do in the department." Jennifer Friedenbach, head of the Coalition on Homelessness, declared, "San Francisco doesn't want Tasers and San Francisco doesn't need Tasers. Instead of prioritizing the trainings and the culture shift that's necessary to save lives of our most vulnerable populations, Suhr is instead promoting a new shiny lethal weapon." Suhr is to hold 3 community meetings before the Board will revisit the issue early next year

Out of 170 people killed by tasers in California, 41.15% were Latino. These killings date as far back as 1983, and the number of deaths have increased each year since. At what is called, "the official taser web site", you can choose you favorite colors taser yellow, fashion pink, electric blue or red hot for only \$399. Competition for sales has some manufacturers claiming their products have higher voltages. Voltages listed today are 100

times those of earlier versions. One company states that if you hold the gun long enough any voltage works.

#### **Secure Communities**

This newsletter frequently reports on how the federal Secure Communities program disrupts and terrorizes the immigrant community. Under this program fingerprints of anybody who is arrested for any reason are sent to the Dept. of Homeland Security and compared to its data base of "illegal immigrants." Then the Dept of Immigration & Customs Enforcement (ICE) asks local authorities to hold anyone it wants to deport. Thus people arrested are immediately at risk, regardless of whether the arrests were justified, dismissed (stop and frisk)," driving while black", minor misdemeanors (fighting in the playground), broken taillights, or subsequently proven innocent in court.

Various counties reacted differently to ICE's request, from immediate compliance—Alameda, Contra Costa, San Mateo– to holding inmates only if they have felony convictions—San Francisco. The California legislature passed a Bill by SF Assemblyman Tom Ammiano requiring all California counties to follow SF policies, but Governor Brown vetoed it. Ammiano has introduced a new version of his bill in the current Assembly.

In early December State Attorney General Kamala Harris advised police and sheriffs that turning arrestees over to federal authorities is not mandatory or legally binding as claimed by Secure Communities. She also commented that the federal claim of focusing on deporting only serious criminals hasn't been true in California, where 28% of those deported had not been convicted of any crime.

#### No National Guards in our Schools

With the tragedy of Sandy Hook we all need to address the culture of violence. Many solutions are necessary from more funding for mental health programs, banning of assault weapons and ending the culture of violence But putting the National Guard into our schools, as proposed by Senator Boxer, is not a solution. Youth have better ideas. Students in L.A. are holding month-long vigils to end violence in schools. Youth Alive in Oakland provides advocacy programs, and they convinced the Oakland Tribune to end gun ads.

#### **Diablo Canyon Nuclear Plant**

PG&E, the owner of the Diablo Canyon Nuclear Power Plant, wants the U.S. Nuclear Regulatory Commission to renew its operating licenses to potentially extend the plant's life through 2045. To bolster its requests it proposed to map offshore earthquake faults by blasting the seabed with air cannons. But environmentalists and fishermen bitterly protested that such studies would cause major disruption of the marine environment. In November the California Coastal Commission unanimously rejected PG&E's proposal. The Commission said that PG&E is convinced that Diablo Canyon is earthquake safe, no matter what the studies might show.

# San Onofre Targeted to open April 2013?

The reactors at the plant have been shut down since January 31, 2012 due to radiation leaks. San Onofre has for the past 6 years had the highest rate of failures in the US along with the highest rate of retaliation against whistleblowers. Southern California Edison plans to operate the plant while cutting the workforce by 50%. Only 2 years after the replacement of defective parts, which cost \$1billion the replacements already are showing wear. The infamous Peevey, head of the CPUC, says that ratepayers should pay for this cost – just like SFPUC is allowing PG&E to pass along to us the cost of their gas pipeline explosion. ## No Fracking in California

Governor Brown caved in to the coal and gas industry when he released his draft of California fracking regulations. The proposed "regulations" allow companies to keep secret the chemicals used. Health professionals who treat patients exposed to these chemicals must sign non-disclosure agreements. Companies responsible for spills have 5 days before reporting. Nor does the industry have to conduct baseline tests of air and water, therefore there would be no way to document damages caused. These regulations also do not require any seismic evaluation.

# Taking Our Money Out Of Wells Fargo!



On Tuesday, December 18, Gray Panthers and Senior Disability Action (SDA) closed their accounts at Wells Fargo to protest the bank's fraudulent and predatory foreclosure practices and triumphantly joined the protest rally outside the bank.



(Several months ago, we had transferred most of our account to Redwood Credit Union.) The demonstration was sponsored by over 13 SF organizations and led by SDA and GP. It called on other organizations to also take their money out of predatory banks. Wells Fargo has been fraudulently processing mortgage documents with a practice called robo-signing for years. Employees were given

daily quotas of foreclosure files to sign, while other documents required for homeowners to avoid foreclosure were ignored. Wells Fargo has double the number of foreclosures of other banks.



We urge all organizations and individuals to take their money out of Wells Fargo and all the other predatory banks!

#### The Courage To Hope How I Stood Up to the Politics of Fear by Shirley Sherrod with Catherine Whitney Simon & Schuster. 240 pp.

Shirley Sherrod was the Georgia State Director of Rural Development for the US Dept. of Agriculture (USDA). In July of 2010 a conservative blogger posted an edited video of a speech she made that seemed to be making racist, anti-white remarks. Without hearing her side or seeing the full text of the speech that the blogger had so carefully edited, the USDA demanded an immediate investigation of Shirley Sherrod.

The Courage of Hope is Sherrod's story not only of that headlong, shameful capitulation to the system's right wing by the Obama administration, but of her lifelong participation in the civil rights struggle, along with her husband, Charlie, a major figure in the fight against Jim Crow. It is a moving and fascinating history. It is also told from a viewpoint most of us don't often meet—that of a deeply committed Christian faith that influences and inspires every action. This book is highly recommended and is available in the public library.
