A Bit of History

On July 15th 1910, over 20 unions met at the location of 2940 16th. In June 1911, the Hall Assoc. came to terms with owners, the Spreckels family' and completed a mortgage agreement. Ground was broken for construction of the building on June 1st, 1914, and the Redstone was dedicated on Labor Day morning September 7th, 1914.

Update On Lynne Stewart

Last month's newsletter reported that the warden at FMC Carswell Prison in Ft. Worth, Texas, where Lynne Stewart is incarcerated, recommended her

immediate compassionate release. This was based not only on her critical physical condition, but also the deluge of petitions for her release that he received. Hooray, our article concluded; we rejoice in this victory. As of the end of May, there is no joy and the victory is hollow. As Lynne says "Today the papers are still on a desk in Washington, D.C., even though the terminal cancer that I have contracted requires expeditious action. Although I requested immediate action by the Bureau of Prisons, I find it necessary to again request immediate action from you, my friends, comrades and supporters." On My 30, these action calls were made on Lynne's behalf.

Could You Use an Extra \$800 a Year?

A bill introduced Sen. Tom Harkin (D-IA) called "The Strengthening Social Security Act of 2013," (S.567) would put as much as an extra \$800 in your pocket every year. Sen. Harkin addressed over 4,000 Alliance members in a Telephone Town Hall. The bill also increases the Cost of Living Adjustment (COLA) to better reflect the cost of goods and services typically used by older Americans; strengthens the Social Security Trust Fund; and ensures the program is solvent for decades to come. Ban All Fracking in California

Fracking uses millions of gallons of water mixed with undisclosed toxic chemicals, pumped deep underground at high pressure to release trapped pockets of oil or gas. The process has contaminated groundwater across the country. Since 1990 more than 90 percent of the natural gas wells in the country have used the fracking process.

In April, a precedent-setting victory against fracking by a federal judge ruled that the Obama administration violated the law when it issued oil leases in Monterey County without considering the environmental impacts of hydraulic fracturing. "This important decision recognizes that fracking poses new, unique risks to California's air, water and wildlife that government agencies can't ignore," said Brendan Cummings, senior counsel at the Center for Biological Diversity, who argued the case for the plaintiffs.

A number of fracking bills have been introduced in the Legislature and state regulators have proposed an overhaul of the state's oil and gas regulations. AB1323 and AB649 call for an advisory committee to review health, environmental, economic, and other factors. Two other bills call for state officials to decide by January 2019 if fracking should be in California at all. We can protect California temporarily with AB 1301, introduced by Assemblymember Richard Bloom, which will impose a moratorium on fracking until more legislation outlines how fracking can occur safely. But progressive coalitions will have to continue fighting, educating the public and countering the oil & gas corporations' propaganda. California was the third largest producer of these fossil fuels last year. See our Sept 2012 and Jan 2013 articles for more



World-Wide Marches Against Monsanto

May 25 "March Against Monsanto Day" protests were

held in 52 countries and 436 cities, including SF with over 1,000 in Union Square. Protests took place in cities of Argentina, where Monsanto's genetically modified soy and grains now command nearly 100 percent of the market.

Bradley Manning Speaks For Us All

Gay Liberation Front activists of the '70s, with our clarion call "Come out of the closets and into the streets", marched every June also to end all wars and all forms of oppression. In intervening years, the June "Pride March" has become a "Pride Parade" sold out to corporate sponsors, BofA, Wells Fargo, Clear Channel. This year progressive LGBTQ activists are outraged that the Pride Committee rescinded the nomination of Bradley Manning as a Grand Marshall in the annual event. The Pride Committee vilified Manning stating that he was not a hero and even a "hint" of support for Manning would not be tolerated!

Our LGBTQ whistleblower, PFC Bradley Manning, spent his 2012 25th and third birthday in a military prison. Bradley was arrested in May 2010 in Iraq on suspicion of having passed classified material to the Wikileaks website. Wikileaks founder Julian Assange praised Bradley Manning as a hero who revealed to the world the 2007 Baghdad air strike by an American helicopter killing innocent civilians. Bradley spent his first 9 months of pre-trial incarceration in a 6×8 ft cell in solitary conditions described as "degrading and inhuman" by the United Nations. Bradley has been tortured, humiliated, isolated and faces a court marshal. He struggles in an environment hostile to him for his gender identity. Because of Bradley's bravery, the world witnessed the true horrors of war. Bradley remains strong and like many youth talks of his future, to be free to go to college. "I want to make a difference. I want to make a difference in this world." You have made a difference. All of us thank you, PFC Bradley Manning

Oakland Police Reform

San Francisco Democratic Party County Central Committee Resolution to End Unlawful Drone Strikes, Extrajudicial Executions, And Restrict Domestic Drone Surveillance:

BE IT RESOLVED,

that the California Democratic Party stands in opposition to the extrajudicial killings and use of drones as described herein, both foreign and domestic, and urges that our policies be structured within the framework of international law, Constitutional checks and balances, due process, judicial review, and transparency; and

BE IT FURTHER RESOLVED,

that we call upon the Congressional delegation and the White House to: Make public all claimed legal justifications of present policies and practices; Conduct a fundamental reevaluation and overhaul of current practices by reforming the policies authorizing the use of American military force, both foreign and domestic; and reinstitute Congressional authority and oversight with regard to war making powers and federal law enforcement.

This Resolution proposed by Hene Kelly and Denise D'Anne, Co-sponsored by: Karen Bernal, Margarita Lacabe, John Burton, Peter Leinau, Rick Tuttle. The Harvey Milk LGBT Democratic Club and Gray Panthers of SF also passed resolutions against drones.

City College

The California Federation of Teachers filed a formal complaint with the Accrediting Commission of Community and Junior Colleges in Novato and the US Department of Education , which oversees the Commission, accusing the Commission of violating state and federal laws and of engaging in conflicts of interest when it put SF City College under its most severe sanctions called "show cause" and threatened to revoke its accreditation. Such a revocation would close City College. The Commission's ruling is due in late June or July.

The Domestic Workers Bill of Rights

The Domestic Workers Bill of Rights (AB 241, Ammiano, SF) has been approved by the Assembly Appropriations Committee and now goes to the full Assembly for approval.

We have been reporting regularly on the Oakland Police Department (OPD) because it is the prime local example of a department that abuses its powers, threatens every progressive demonstration, protects its rogue officers, resists every effort to reform, and epitomizes the mentality that says the police exist to protect the establishment not the citizenry. Oakland, of course, is not alone in its attitudes; how about SF police and Occupy?

The OPD has been under federal court-ordered supervision for over ten years. The court-appointed compliance director, Thomas Frazier, filed a report last month that said the OPD top brass doesn't punish officers' misconduct, does a poor job of investigating citizen's complaints, and consistently finds every action taken by an officer was taken appropriately, even though those actions included use of excessive force, concealing of names and badge numbers, turning off cameras during crowd control to prevent a record of what they were doing, and pointing weapons unnecessarily at suspects. Frazier's report blamed top management and the prevailing culture in the department for blocking effective reform.

On May 9 OPD Police Chief Howard Jordan suddenly resigned because of medical problems "I was never forced out" he said. In 2011 former chief Anthony Betts resigned after a similar critical evaluation from a court-appointed monitor. On May 10 the Oakland mayor and city administrator replaced most of the department's leading commanders. It remains to be seen how effective these actions will be this time around.

Corporate Tax Avoidance

We have been reporting in the Newsletter (June, 2012, Feb., 2013) about the tricks multinational corporations employ parking their incomes overseas to avoid paying US taxes. Periodically Congress holds hearings on these shenanigans, generating indignant headlines and no action. In April a New York Times story highlighted Apple and its machinations that reputedly saved it \$9 billion in 2012. Apple retorted indignantly and accurately that everything they did was legal. What they didn't say was that it was legal because the multinationals' lobbyists and money persuaded Congress to write tax laws full of loopholes.

California Coastal Commission Decision

On Thursday, May 9, The California Coastal Commission allowed the SF Recreation Department to go ahead with its plans for an artificial turf for the Golden Gate Park Beach Chalet soccer field.

The majority of the speakers during the hearing were proponents of the soccer field. Only a few spoke against the proposal since most came late and were refused speaker cards. However, one Gray Panther member, Lynn Gavin, who is partially disabled and one of a few black people in attendance, using the threat of ADA, demanded to be heard and spoke eloquently.

Only one commissioner spoke in favor of the staff report that opposed the proposed soccer field. That c o m m i s s i o n e r a r g u e d t h a t t h e Commission's mission is to protect the coast and that it should not be swayed by any arguments put forth by the proponents or SF City officials...

Apparently none of the remaining commissioners agreed. They did argue for some kind of mitigation. One was to restore 4 acres contiguous to the 7 -acre soccer field to its natural state. SF Ocean Edge and The Golden Gate Park Preservation Alliance successfully rallied against using this land for a treatment plant. A fact apparently unknown to - or ignored by the commissioners - is that Rec and Park was proposing to restore this land to "habitat". Kathy Howard, a leader of the fight against despoiling the grassy soccer field, said "What kind of habitat would this be, right next to 50,000 watts of stadium light that will be turned on until 10:00 pm every night." Possible health issues were not even discussed.

Save CEQA

CEQA - the California Environmental Quality Act was passed 43 years ago to help keep California clean and green. Now efforts are being made statewide and locally to weaken the Act by reducing the amount of time citizens have to review and appeal environmental impact of proposed projects and by restricting lawsuits meant to protect the environment. These efforts are made in the name of expediting development and making it easier. CEQA gives the public a say in development projects that would have a significant effect on their surroundings, like 8 Washington and the proposed Warriors waterfront sports arena.

Genetically Modified Food

The Genetically Engineered Food Right to Know Act was introduced in Congress last month by CA Senator Boxer and Oregon Rep. De Fazio, requiring the FDA to label genetically-modified food ingredients, including 70-80% of processed foods sold in the US like corn, soybeans, sugar beets and cottonseed oil. It is similar to Prop. 37. Eight EU countries have banned Monsanto's GMO crops, and China has destroyed at least 3 GMO corn shipments from the United States. Hungary destroyed acres of Monsanto's GMO corn fields.

Chained CPI and Social Security

The Consumer Price Index (CPI) determines cost-ofliving-adjustments (COLA) that are supposed to protect Social Security benefits from inflation based on a typical market basket of all consumer purchases. Some senior groups think it should be based on a market basket of senior/disability expenses, medical costs and caretakers. Instead the Obama administration proposes Chained CPI(C-CPI). that says when market basket purchases get too expensive, consumers will shift to cheaper substitutes, like Fords instead of Cadillac's! With C-CPI your COLA and Social Security benefits will be less forever!.

Rep. Cicilline (D-RI) introduced HR 34 opposing CPI supported by over 81co-sponsors! Senators Harkin (D-IA), Sanders (I-VT) and Whitehouse (D-RI) introduced SR 15 also opposing C-CPI.
