# **Standing Rock Around the World**

The Standing Rock Sioux and 2000 or so supporting Water Protectors camped out to oppose the Dakota Access pipeline (DAPL). As I write this on Dec. 26, the water protectors are sitting through a blizzard with 5-foot drifts of snow. Fortunately, this historic resistance action is getting some mainstream reporting. Its great significance is not being entirely lost in the present bad news coverage.

This morning, Bernie Sanders on an hour-long Democracy Now special, KPFA.org outlined three reasons why he opposes DAPL: 1) First and foremost, flat-out, because it's a matter of Native Americans' historic Treaty rights, once again being discounted; 2) the threat to the water supply for many thousands from a possible burst pipe under the Missouri River; and 3) the pressing need to convert our energy sources from environmentally damaging fossil fuels to renewable energy sources. This program is highly recommended listening. KPFA also offers transcriptions to read.

Sanders also pointed out that he has written to the administration that the kind of military presence that has been in play is not acceptable.

Supporters of the Water Protectors are cropping up all over the nation and the world. Caty Powell of Gray Panther in Sonoma County tells of many in Sonoma County who are actively supporting the Water Protectors in Standing Rock. Although the Army Corps of Engineers, as a result of the ongoing nonviolent opposition, has for now put the completion of the pipeline on hold. Pending a full environmental review, continued vigilance is required as the investors (including Trump) have not given up their nefarious plans. Court actions are pending.

The article, "Standing Together," from the December 13 Sonoma County Bohemian that Caty forwarded to us (copy available upon request at 415-558-2800 or at http://tinyurl.com/hd3mhr4) quotes a local Dakota Sioux/Chippewa resident, Adam Villagomez, who drove to Standing Rock for a week's stay with his wife and three children: "Standing Rock is only the leading edge of a much larger spiritual-political phenomenon that involves recognition of indigenous sovereignty, water protection and climate change activism." Exact same 3 points that Bernie made, but with the additional

historical background: some of the power of the non-violent resistance stems from the 12/29/1890 massacre of 300 Lakota men, women and children at Wounded Knee, S.D., which to the Lakota effected the shattering of the 'Sacred Hoop': "My understanding is that the movement at Standing Rock is the fulfillment of multiple prophecies that involve our people coming together, standing up and mending the Sacred Hoop," Villagomez says. In short, there is deep historical/spiritual significance to this resistance that promises to give it special power.

A large number of corporate investors are funding this pipeline project. Wells Fargo is one. Numerous protests and demands for divestment have been made of Wells Fargo around the country, and another is sure to be planned soon. Can you be there to represent Gray Panthers' support of the Water Protectors? To say, "Can't drink oil?" To take part in history? Meanwhile, have you considered closing any account you may have at a big bank and switching to a community bank? Why not do that?

Those of us who are concerned about global warming should not shop at Amazon, holiday or no holiday.

Amazon packaging includes the cutting of countless trees, the use of oil to ship, manufacture plastic and bubble wrap. Most Amazon products are made in other countries preventing homegrown products to get a foothold. The negative impact on our air quality and use of fuel is incalculable.

Some 36,000 robots at work in Amazon warehouses are replacing American jobs. On Friday, Dec 9th, we celebrated the Universal Declaration of Human Rights by reading it at City Hall. On September 13, 2007, the United Nations decreed that all indigenous people have the right to full enjoyment, that Federal and State governments are obligated to protect and fulfill the rights secured in Articles 1-40 of the Universal Declaration of Human Rights.

#### SFMTA - Rein-In the Rogue Agency

Paul Kozakiewics, a local neighborhood newspaper editor and president of the association of neighborhood newspapers, has a lengthy commentary in several neighborhood newspapers about SF Municipal Transit Authority (SFMTA) and Muni. The commentary, headlined "Rein-in Rogue Agency," calls for taking SFMTA apart and cites all their bad doings.

He wrote, "City voters crushed Prop, K, with about 2/3 of the voters saying "no" to giving more money to a rogue city agency hell-bent on destroying the character of the city's neighborhoods in the name of transportation progress." He goes on to list SFMTA's service cuts and changes all over the city. "It has become apparent to many city residents that the MTA needs to be reformed.... the way the MTA is set up now, the agency is responsible to no one. I could go on all day about the abuses perpetrated by the MTA..."

Kozaklewics continue saying it's time for the SF Civil Grand Jury to take a look, or that voters get the opportunity to vote for more accountability. He suggests that Mayor Lee and/or the Supes have more control over Muni . "A city agency ... should be responsive to the public it serves. A small cadre of planners and appointed directors who are not beholden to anyone should not be redesigning our neighborhoods. Can you name the members of the MTA? It's time we gain control over this rogue agency."

Let's pick up our neighborhood papers to keep informed about what's going on so we can begin picking up the pieces of this limping so-called democracy. How dare they eliminate at least 14 bus stops on Van Ness? How dare they plan to cut down 200 trees on Van Ness? We should insist they be retained. If you dial 311, a real person will answer, and you can speak your message and have it delivered to any City official you specify, such as the SFMTA Board Members. Saving Muni transit stops and getting Muni out from under SFMTA is a good campaign to stick our necks out for.



#### **GP's Post-Election Political Roundtable**

On November 19 a Post-Election Political Roundtable was held at the University of San Francisco. In spite of a stormy afternoon, the room was filled beyond capacity, and nearly 200 attended. Most of the meetings at the time were sharing grief or chagrin over the Trump election, and it was great to get together to instead share anger and determination to fight the Trump agenda.

The event was initiated by the Gray Panthers and co-sponsored by the SF Progressive Democrats of America SF Berniecrats, and SF Vision, and the panel of political analysts and activists included: Lawrence Shoup, author of Wall Street's Think Tank, Peter Dale Scott, author of The American Deep State, Stephen Zunes, author of Tinderbox, David Talbot, founder of Salon Magazine, and Peter Phillips, author of Project Censored. Rebecca Gordon, author of American Nuremberg, got sick at the last minute, and Cheryl Davila, newly-elected to the Berkeley City Council had to cancel.

The panel, put together before the election, was to discus power in the United States--where it resides, who has it, how are decisions made and enforced, and what forms it is likely to assume in the coming period. We, like the media pundits, blithely assumed the election would be an ordinary, orderly handing of power from one hand of the established elite to another. The Trump election upset these assumptions, and, not surprisingly, dominated the discussion of the panelists and especially the questions from the audience, which occupied at least half the afternoon.

Audience members expressed a desire for another meeting. We don't want to duplicate the meetings on action to take. We're planning a forum on US foreign relations and the move to war in March.

#### **Hands Off Social Security**

Social Security, which has reduced senior poverty from 1/3 to 1/10, which has never missed a payment since its beginning in 1935, and which has a surplus of almost \$3 Trillion, is said to be on the verge of financial collapse. Lies! According to the 2016 Social Security Actuary, even if no changes were made, Social Security could maintain today's benefits for 20 more years, and 75-79% benefits after that. Scrapping the Cap, making high-earners pay into Social Security, would let it pay today's benefits forever.

Social Security's nearly \$3 Trillion surplus, paid by FICA deductions from our paychecks, is invested in US Treasury Bonds, considered the safest possible investment. By investing in US Treasury Bonds, Social Security loaned its surplus to the US Government. Unfortunately, the US Government did not put that money into infrastructure, education, scientific research, and health and welfare programs, to grow the economy and increase government revenue to pay Social Security back.

Instead the Government wasted the money on oil wars, bank bailouts, and tax cuts to the rich, accompanied by economic collapse and huge government debt. So now the Government cannot repay its debt to Social Security without either taking lots of money from the rich (God forbid!) or borrowing even more. In other words, the socialed Social Security fiscal crisis is really a government fiscal crisis, brought on by the same set of politicians and corporate think-tanks that now say seniors must lose benefits they paid for, because the government cannot re-pay Social Security. No Way! Make the bosses take the losses!

According to the Economic Policy Institute, HR 6489, by US Rep. Sam Johnson, R-Texas, chair of the Social Security subcommittee of the House Ways and Means Committee, would: (1) gradually raises retirement age to 69 for those currently 49 or younger (a 13.5% across-the-board cut), (2) reduce retirees' initial payments an average of 9%, and (3) cut cost-of-living increases an average of 13%. Some long-lived beneficiaries could see cuts of 74%. See <a href="http://tinyurl.com/jjgypcb">http://tinyurl.com/jjgypcb</a>.

There is a group funded by the notorious anti-"entitlement" Peter G Peterson Foundation to convince college students that Social Security is beyond repair. Its offices are nearby. Stay tuned.

#### Protect, Improve, and Expand Medicare and Medicaid

Medicare provides healthcare to some 57 million seniors and people with disabilities, regardless of income, covering hospitalization (Part A), doctors visits and other outpatient services (Part B), and spotty assistance for buying medicines from private insurers (Part D). Approximately 1/3 of Medicare patients get these and other services through private "Medicare Advantage" (Part C) plans like Kaiser. Hospitalization (Pt A) is paid by workers through payroll deductions. Outpatient care (Pt B) and drug purchasing assistance (Pt D) are paid from the Federal General Fund, but Medicare is an "entitlement." Government must to provide care for all eligible people, no matter what it costs.

Medicaid (Medi-Cal in California) provides healthcare to some 73 million low-income adults. seniors, and particularly children, providing basic coverage for all aspects of healthcare. Federal Medicaid determines who must be covered and what services must be covered, and provides roughly half the financing, but the actual programs are administered by the States. About 1/3 of US births, and virtually all long-term care in the US is financed by Medicaid. 42% of California children are on Medicaid. Obamacare extended Medicaid to 16 million people below 138% of poverty level (\$33,000 for family of four) and paid at least 90% of costs in those 32 states that adapted expansion. Medicaid, too, is an "entitlement." Federal and State governments must pay for all eligible people.

Medicaid/Medi-Cal is in more immediate danger. Within weeks of 2017, Obamacare could be revoked, kicking the 16 million Medicaid Expansion people off Medicaid, and Medicaid could be "block granted," meaning states get a fixed amount no matter what they need, and states could restrict who and what services are covered. This could happen very fast because a Federal budget maneuver called "reconciliation" letting budget crunches change the design of entitlement programs.

Attacks on Medicare are slightly down the road, and include raising the eligibility age, and converting Medicare to a voucher program to buy private insurance whose yearly benefit would not cover even a single night in a hospital.
